




# **An Article V State Constitutional Convention Citizen Ballot**



And as per Article V of the U.S. Constitution, when a majority of voters from 38-States mail in their ballots, the Democracy Amendment will be ratified.

### The “Emergency Clause” in Article V of the U.S. Constitution

*“The Congress, whenever two thirds of both houses shall deem it necessary, shall propose amendments to this Constitution, or, on the application of the legislatures of two thirds of the several states, shall call a convention for proposing amendments, which, in either case, shall be valid to all intents and purposes, as part of this Constitution, when ratified by the legislatures of three fourths of the several states, or by conventions in three fourths thereof, as the one or the other mode of ratification may be proposed by the Congress ...”*

Note the initial reference in Article V to a national singular national “convention,” for proposing amendments -- whereas the second plural reference to “conventions” would have to be organized in each state in order to ratify amendments. And given the last line states the Congress “may” (not shall) propose the state Constitutional Conventions, this clearly means the majority of voters in each state are also empowered to organize their State Constitutional Conventions on their own -- in order to overcome corrupt and/or dysfunctional state legislators, who are less expensive to bribe than the Members of Congress. The corruption of the American Republic is well-known, yet no one in the Congress has proposed to make such bribery of elected officials illegal, in spite of members of Congress who candidly state they spend over 90 percent of their time raising money -- much of which they keep once they leave office. But once the Democracy Amendment is ratified, the Congress will then be operated like the U.S. Armed Forces, with pride and not bribes, with a mission to implement a Solar Hydrogen Age worldwide.

In the case of this citizen-sponsored Democracy Amendment for the United States, there is no need for a potentially chaotic Constitutional Convention to create the amendment (i.e. Article V makes no mention of who would get to go the Convention to draft and vote to approve the amendment) because voters in all 50 states, regardless of their political party registration, are able to simply download the Article V Constitutional Convention Citizen Ballot from the DemocracyAmendmentUSA.org website -- that also provides an Empowering the Majority and other documents that outline the profound energy, economic, healthcare, education and foreign policy implications of having a majority-rule democratically-elected government with completely verifiable paper ballots that are downloaded from, and mailed to, each voters Secretary of State.

### The “Trigger Mechanism” is the Article V ***Constitutional Convention*** Citizen Ballot
